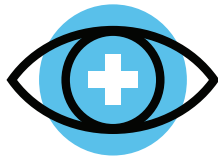


What is GDAHC?

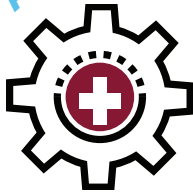
